Subject: Payment to Government servants through e-Payment

In supersession of this office O.M. No. 1(1)/2011/TA/365 dated 1st August 2016 on the above subject (copy enclosed), as per the amendment in Rule 44 issued vide Government of India Notification No. G.S.R. 412 (E) dated 27-04-2017 (copy enclosed), all payments to Government servants, including salary payments, shall be made by electronically signed payment advices for direct credit to their bank accounts, subject to availability of banking facilities:

Provided that a one-time relaxation may be granted for payment by other recognized modes in cases of hardship where the reasons are duly approved by the Head of Department and Financial Adviser.

New Delhi, the 27th April, 2017

G.S.R. 412(E).—In exercise of the powers conferred by clause (1) of article 283 of the Constitution, the President hereby makes the following further amendments to the Central Government Account (Receipts and Payments) Rules, 1983, namely:—

- These rules may be called the Central Government Account (Receipts and Payments) Amendment Rules, 2017.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Central Government Account (Receipts and Payments) Rules, 1983,....
- (i) in rule 33.—
 - (a) for clause (xa), the following clause shall be substituted, namely:—
 - '(xa) When payment is desired by different modes of payments i.e., payment advice/Cheque/Demand Draft/ Postal Order/ Money Order/ Cash, etc., separate bills shall be prepared by the DDOs and the following shall be clearly indicated on the top of the bills:

"Payment by (*)"

(*payment advice or Cheque or Demand Draft or Postal Order or Money Order or Cash)';

OFFICE MEMORANDUM

Subject: Payment to Government servants other than salary etc. through e-Payment

A reference is invited to this office O.M. No. 1(1)/2011/TA/ 292 dated 31st March 2012 regarding payment to Government servants other than salary etc. through e-Payment from 1st April 2012. Since advancements in payment and banking technology have enabled a large number of transactions to be handled smoothly through the e-payment mode, the existing limit of Rs. 25,000/- prescribed in paragraph 2 of this office O.M. dated 31st March 2012 has been further reviewed. It has now been decided to lower the threshold limit to Rs. 10,000/- in order to bring more payments under the purview of direct credit by electronic transfer to the bank account of the payee.

- All Ministries/ Departments of the Government of India are required with immediate effect to discharge all payments to Government servants, other than salary, above Rs. 10,000/-(Rupees Ten thousand only) by issue of payment advices, including electronically signed payment advices.
- In so far as payment of salary is concerned, employees may continue 3. to have the option of drawing salary by cash, cheque or electronic payment mode irrespective of the amount involved.
