# **PhD** (Part Time) Programs

# (Started from July 2019)

# A. Guidelines, Rules and Regulations for General Candidates:

- **A1**) The candidate should have 5 years of experience before applying to the program, with NOC (Annexure -III) from the head of Institute.
- A2) Minimum duration of the programme (i.e. upto thesis submission): 4 years
- **A3**) Place of work: VNIT Nagpur
- A4) Course work is to be completed at VNIT Nagpur within 1 year of admission.
- **A5**) Contact duration: minimum attendance in VNIT: 15 days per non-course semester.
- **A6)** Payments of Fees (Non-Refundable) (Subject to the revision from time to time)

- **A7**) No financial assistance / fellowship / Teaching assistantship will be paid from VNIT to candidates admitted under this category.
- **A8**) Other guidelines, rules and regulations governing PhD (Full time) programs January 2019 are applicable to PhD (Part time) Programs July 2019, also.
- **A9**) Eligibility criteria, admission process and schedule is same as of PhD (full time) program July 2019.
- **B. TEQIP-III Ph.D. (Part time):** Candidates appointed as Assistant Professor (Temporary) under TEQIP-III are eligible to apply for Ph.D. (part time) programs with following guidelines, rules and regulations.
  - B1) Candidate should be appointed as Assistant Professor (Temporary) under TEQIP-III with NOC (Annexure IV TEQIP-III) from the head of Institute.

- B2) Course work is to be completed at VNIT Nagpur within 1 year of admission.
- B3) The all rules A1 to A9 of Ph.D. (Part time) programs, except A1 and A3, are applicable.
- B4) Financial support is limited to the completion of TEQIP-III and to be borne by the deputing or the respective institute.
- B5) Guidelines provided by the letter NPIU/TEQIP III/Acad/442 dated June 5, 2018-Annexure-1 will be followed.

# C. Conversion of Full Time PhD to Part Time PhD for the Scholars left the PhD (Full Time) from Jan-2014.

The scholars who had joined the Full time PhD but left or discontinued from Jan 2014 due to some reason and could not convert to Part time program due to its non-availability can join the Institute for part time PhD with following conditions.

- C1) The candidate should have previously completed minimum two years of the duration after registration.
- C2) He/ She should have completed the course work as well as progress seminars (minimum 4 seminars).
- C3) The candidate will have to pay the fees as per the norms of part time program started from July 2019.
- C4) He/ She should have to submit fresh NOC from appointing authority /parent organization / Employer.
- C5) All other conditions stand same as proposed for part time Ph.D. Program effective from July 2019.
- C6) Last date for admission to July-19 to Dec. 19 semester is 05<sup>th</sup> July 2019.
