Representatives of CPWD (Elect.), PWD (Civil) & (Elect.) could not attend the meeting due to their pre-occupation.

At the outset Chairman welcomed Dr. N. S. Chaudhari who will be taking over the charge of the Director VNIT Nagpur today and requested the members to extend co-operation during his leadership.

The Committee discussed the agenda and resolved as under;

BWC 30.01 To note the minutes of the 29th meeting of the Building and Works Committee held on 18th March 2013.

The minutes fo the 29th meeting were confirmed.

BWC 30.02 Action taken report on the minutes of the 29th meeting of the BWC held on 18th March 2013.

Noted the action taken report with following suggestions;

As regards 29.07 pertaining to installation of solar power unit, the Chairman informed that NIT Trichi is recently entered into contract with BHEL Bangalore for 100 KV unit. The team of VNIT shall, therefore, visit NIT Trichi to examine the proposal and re-submit the proposal for 100 KV unit in next BWC meeting.

As regards 29.08 it is decided to go for expression of interest, draw specifications and finalise those specifications based on Indian Certification agencies.

BWC 30.03 To approve the tender for work of construction of extension of department of Chemistry, Physics and MEC Buildings.

Approved as proposed.

BWC 30.04 To approve the tender for the work of construction of extension of Electronics Department & Recreational facility for H.B. No. 3 & 4.

Approved the tender of M/s Mana Construction. However, considering past experience, the work be monitored for timely completion.

BWC 30.05 To approve the detailed estimates of extension of Computer Science Building.

Approved as proposed.

BWC 30.06 To approve the detailed estimates of Civil work at ground floor of transit accommodation building.

Approved as proposed.

BWC 30.07 To approve the detailed estimate for furnishing of Professor's & Associate Professor's quarters.

Approved as proposed.

BWC 30.08 Any other item(s) with permission of the Chair.

(A) Sewage treatment plant for reuse of treated wastewater for gardening and toilet flashing.

Approved in principle.

(B) Demolition of old Girls Hostel building.

The old Girls Hostel building which was built more than 30 years has accommodation only for 40 girls. There is no scope for vertical expansion as the building was constructed for G+1 design. With the rapid increase in girls students intake, the accommodation is insufficient. This was deliberated and the BWC resolved to dismantle the old girls hostel building so that the same space can be used for construction of multi-storied (G+11 storied) building which will accommodate at least 600 girls.
