S 23.01 To note and confirm the minutes of the 22nd meeting of the Senate held on 15th March 2011.

While noting the ATR on S 22.03, the Chairman informed the Senate that the NIT Council in its 2nd meeting decided that the DASA students will be admitted through "On Line AIEEE" from next year.

S 23.03 Institution of Parag Tijare Memorial Award.

Ratified.

The Senate also recommended that the amount of Cash Award be enhanced in consideration of present price index or convert the cash prize into medal, in consultation with those instituted the prize.

S 23.04 Contact course of odd term (2011-12).

Ratified the proposal of the contact course with the suggestion that the faculties be made available in all the departments with consent of the Senate.

The HoDs of Applied Science Departments were suggested to give one page synopsis focusing the area in which the M.Sc. programmes are to be proposed.

S 23.05 Provision of syllabus of Demography and Statistics – Department of Mathematics.

Ratified the syllabus of Demography and Statistics.

S 23.06 Course work for Ph.D. scholars in Department of Architecture.

Ratified the course work.

S 23.07 Recording attendance and reinstating "W" grade.

Ratified the recording of attendance as "W" grade with the noting that the paper of such students (who is recipient of "W" grade) will not be evaluated.

S 23.08 Modification in the Scheme of Instructions of M.Tech. (STR) and M.Tech. (SDEE).

Ratified the modifications.

S 23.09 Self Study Course for Ph D scholar in Department of Chemistry.

Approved a course in Chemistry of Industrial Waste Lignin and its Recent Applications (CHL-505) as a "Contact Course".

S 23.10 Addendum to rules regarding Cumulative Grade Point Average (CGPA).

Approved with suggestion that the required CGPA should be achieved in 6 semesters. It was further decided that disclaimer / advisory note to that effect shall appear on Grade Card.



S 23.11 Departmental Electives in lieu of Open Courses.

It is resolved that UG students can take Department Electives of their respective departments in lieu of open courses(OC) and humanities courses. Maximum number of open courses students can take will be two. Maximum number of humanities courses after first year will be one. All other credit requirements remain unchanged.

S 23.12 Guidelines for registration in Interdisciplinary Board of Studies.

It was resolved that the proposal be re-submitted with further clarification along with the data.

S 23.13 To approve the scheme of M.Tech. (Communication System Engineering).

Approved the induction of M.Tech. Communication System Engineering programme in Department of Electronics Engineering in principle along with the scheme as proposed by the BoS.

S 23.14 To recommend the lists of students / scholars and for conferment of degrees and winners of awards / medals.

Recommended the list of students / scholars for conferment of degrees and a list of winners of awards and medals to be given during 9th Convocation.

S 23.15 Any other item(s) with permission of the Chair.

a) BoG nomination on Board.

Noted the nomination of Dr. A. G. Kothari, Professor of Electrical Engineering and Mr. I. L. Muthreja, Asso. Professor in Mining Engineering, on the Board of Governors as teacher representatives.

b) Recruitment of faculty.

Noted the proposal regarding number of faculty positions (Professor – 05, Asso. Professor – 14, Asst. Professor – 36) to be advertised with approval of the Chairman, board of Governors.

c) Selection of non-faculty staff.

Noted the proposal to conduct selection interviews of non-faculty (advertisement issued in August-2010), immediately after Convocation.

d) Re-constitution of Stores-Purchase Committee.

Noted the re-constitution of Stores Purchase Committee as approved by the Chairman, Board of Governors.
