S 24.01 To note and confirm the minutes of the 23rd meeting of the Senate held on 29th August 2011.

S 24.02 To note the Action Taken Report on decisions of the 23rd meeting of the Senate.

Noted.

S 24.03 To start M.Sc. programmes in Applied Sciences Departments.

The Senate approved the proposal to start M.Sc. programmes in Physics, Chemistry and Mathematics with following suggestions.

- I. 1. The nomenclature of computer programming shall be Scientific computing.
2. Scientific computing and communication skill shall be common to all the three M.Sc. courses.
3. Admission criteria shall be B.Sc. in Physics, Chemistry and Mathematics or Biology with not less than 55% marks.
4. Intake capacity shall be 15 per course.
5. The admission shall be through Common Entrance Test for M.Sc. at all India level i.e. Joint Admission Test for M.Sc. (JAM) or / and local test conducted by the Institute.
6. The Elective course shall bear the code number of concerned engineering department's subject.

II. As regards the course of "Communication Skill", the Senate resolved that it should be treated as Audit course with 3 lectures per week.

S 24.04 To approve the course contents for departmental electives in Architecture.

Approved as proposed.

S 24.05 Course work for Ph.D. scholars in Architecture.

Approved as proposed.

S 24.06 Change in overall credit structure of M.Tech. (Construction Technology &

S 24.07 Modification in evaluation process.

The Senate advised that the matter shall first be discussed at Departmental level, examine merits and demerits of the Scheme and prepare a comprehensive note to be discussed in next Senate meeting.

S 24.08 Guidelines to tackle the problems of student's indiscipline.

The Senate constituted a Committee comprising Dr. V. A. Mhaisalkar as Co-ordinator and Dr. S. S. Umare, Dr. A. P. Patil and Dr. A. D. Ghare as member.

The Committee shall formulate guidelines and put up for consideration in next Senate meeting.

S 24.09 Consideration of credits completed during the PhD research studies at Nagoya University, Japan.

Approved as proposed.

S 24.10 To consider the number of extra-curricular and co-curricular activities in academic year.

The Senate resolved that there shall be Institute Gathering (IG), preferably in December and two more Co-curricular activities i.e. Axis in Odd Semester and Aarohi in the Even Semester. No other co-curricular activities will be entertained.

S 24.11 Extension of provision to M.Tech. students for registering for PhD programme.

The item was withdrawn.

S 24.12 Modification in name of the Department of Humanities.

Approved the change in name as 'Department of Humanities & Social Science'.

S 24.13 Provision for internships in Academic Calendar.

A Committee comprising Prof. R. M. Patrikar, Dean (Acad), Prof. O. G. Kakde, Dean (R&C) and Prof. S. B. Thombre, I/c T&P shall look into the matter and place its considerations in next Senate meeting.

S 24.14 Any other item(s) with permission of the Chair.

D) Ratify the notes approved by the Chairman.

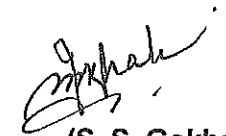
The Senate ratified the following notes approved by the Chairman.
