For point no BWC 40.06, Finance Committee in principle approved the procurement of furniture with a suggestion that the procurement should be done looking into the furniture of the similar institutes. F 42.03 To review financial status of ongoing new construction project (NBCC Ltd)

VNIT has entered into a MOU with NBCC (National Buildings Construction Corporation Ltd) on 12 Nov 2014, for construction of new civil works for a total approx. cost of Rs.210.00 Cr with details as follows

NBCC Ltd. work is as per schedule and they have raised the demand of Rs.25.57 Crores based on the actual expenditure. This payment has to be made immediately for smooth progress of the construction work. The institute had requested MHRD to release Rs. 62.50 Crores for the period 1st July to 30th September 2016. However, MHRD has released Rs.33 Crores only till 31st October 2016, which have already been utilized completely and there is a deficit of Rs.29.25 Crores in plan grant for financial year 2016-17. In the third quarter, the institute has requested MHRD, Rs.60.80 Crores requirement for this construction activity to progress smoothly.

FC is requested to recommend early release of plan grant funds to institute for smooth and speedy progress of the work.

Resolution: The Finance Committee resolved that the funds to the extent available be utilized and the payments that are due be released.
