VNIT, Nagpur has been listed in Annexure VII by SECI as a proposed site for installing roof top solar PV system by the said firm.

The firm has done preliminary work to ascertain the rooftop capacities of various buildings on VNIT campus and the M/S Clean Max Enviro Energy Solutions Pvt. Ltd., Gurgaon has agreed to give the detailed presentation to BWC.

M/s NBCC Ltd. has submitted a Govt.Registered valuer report for the usage of above land admeasuring 2196.115 Square meter utilized for the batching plant and the rent applicable is Rs.79610/-per month. This rate is as per Govt. Registered valuer is a nominal rate to be considered as 25% value of Ready Reckoner. i.e Rs.36/-per square meter since M/s DEE VEE PROJECTS LTD. has carried out work for the VNIT Site only and thus deserves this nominal rate proposed by the Govt. Valuer.(Annexure- II)
