

59.03: To Adopt the Recruitment Rules for Non Teaching Officers and Staff of VNIT Nagpur as per the recommendations of Oversight Committee.

The Recruitment Rules for Non Teaching Officers and Staff as per the recommendations of Oversight Committee. (as per circular no F.33-2/2012-TSIII dated 20th December 2017) are enclosed in the **Annexure-II.**

The Board is requested to approve the RRs.

Resolution: The BoG adopted the Recruitment Rules for non teaching officials and staff of VNIT, Nagpur.

59.04 To consider the matter related to Shri Namdeo D Suryawanshi, Pharmacist, VNIT Nagpur.

Shri N. D. Suryawanshi has joined VNIT Nagpur on 6.4.2005 as **Compounder** in the Scale of Rs. 4500-7000 (PB-1, GP 2800/- w.e.f. 1.1.2006). He was re-designated as **Pharmacist** with effect from 25.6.2010. After completion of 10 Years service he has been given MACP. (PB-II, GP 4200/-.w.e.f 7.4.2015)

He has put up as Grievance that he should be granted the scale of PB-II with GP 4200 after completion of service of 2 years in PB-1 GP 2800/- as per MHRD Circular No. 14-4/2009-TS-III dated 1st Oct., 2012 and Ministry of Finance O.M. No. 1/1/2008-IC dated 18.11.2009.(Grievance of Shri N. D. Suryawanshi is enclosed in **Annexure-III)**

The matter was reviewed by Dr. G. P. Singh Committee and Committee recommended the same to be granted after conduct of DPC. The said report has been sent to oversight committee duly constituted by MHRD for looking into grievance of non teaching staff for its due consideration.(Dr. G. P. Singh Committee report enclosed in **Annexure-IV**)

In council meeting of NITS, as per item 10.7 of Minutes for the Meeting held on 26.5.2017, recommendations of the oversight Committee constituted to look into the anomalies of the non teaching staff in NITs were deliberated. The Council accepted the recommendation of the oversight Committee.

MHRD vide their letter No. F.33-2/2012-TS.III dated 20.12.2017 forwarded the revised Recruitment Rules (RRs) for Non Teaching staff in the NITs clearly mentioning that "Those who have been recruited as per the RRs issued on 5th February, 2014 will continue to be governed by the same."

Hence, BoG is requested to deliberate.

Resolution: The BoG resolved to refer this matter to MHRD.

In recognition to the achievements under the MoU, Executive Director, ISGI has indicated willingness to renew the prior MoU for further period of one year (Annexure-VII)

59. 10: The Faculty Recruitment at VNIT, Nagpur under 4 tier flexible Faculty Recruitment norms.

The advertisement for various faculty positions is given in various News Papers and also placed at VNIT website on 12th December, 2017. Internal candidates were also advised to submit their applications if they qualify as per letter MHRD F No 33-9/2011-TS.III dated 6th October, 2017 and MHRD F No. 33-9-2011-TS III dated 17th November, 2017 with one time relaxation and mapping. The list of applications received for various positions department wise is given in **Annexure-X**. The Scrutiny of the application received before last date as per norms is in progress.

As per NIT Statutes, 2017 (23) 5 (a), the Selection Committee constitution for the appointment of academic staff consists of (as per clause (3)) "two nominees of the Board, one being an expert, but other than the member of the Board".

In previous rounds of Faculty Recruitment the Board Nominees were Professors from IIT / NIT, IISER, IISC, National level Institutes and the Chairman, BoG has approved these selections.

Accordingly, BoG is requested to accord the approval to any Professor from IIT / NIT, IISER, IISC or National level Institutes like Indian Statistical Institute (ISI), Harischandra Research Institute (HRI), Allahabad, Institute of Mathematical Sciences, Chennai etc. be nominated by the Board, one out of which would be a Professor in the respective discipline who would be subject expert.

Resolution: The BoG approved the proposal. For completion of Selection Panel, BoG approved that the one of the Senior Professor will be included as a Member when HoD / his or her relative is an applicant or HoD is not able to participate.

59.11 To extend Lease of Maha Vitran for Sub-Station.

VNIT Nagpur(Erstwhile VRCE) has given land on lease to MahaVitran(Estwhile MSEB) for erecting Sub-Station for Power Distribution to VNIT Nagpur and other part of locality. The Lease was for 30 years and which will be terminating on 30th December 2018.

Maha Vitran has submitted a request letter for renewal of Lease. The proposal from Associate Dean(Electrical Maintenance) is enclosed in **Annexure-XI**

BoG is requested to approve.

Resolution: BoG approved the renewal of lease of land for its use by Maha Vitaran at a monthly rent of Rs. 1,97,442/- w.e.f. 1st January, 2019 and asked the Institute to send this proposal along with draft agreement to MHRD for its consent. BoG further resolved that the agreement should be renewed every year with fresh terms and conditions and with a prior approval of Ministry of HRD.

59.13.01 To recommend request application of Ms.Mansi Radke, Comp.Sc.Dept.

As per BoG resolution, Ms.Mansi Radke, Assistant Professor on Contract has been terminated with effect from 22nd January 2018. (Annexure-XIII)

55.11 To consider request application of Ms. Mansi Radke, Assistant Professor on Contract in Computer Science and Engineering.

Ms. Mansi Radke has been appointed as Assistant Professor on Contract in Computer Science and Engineering Department in Pay Band(PB)-3with AGP of Rs. 6000/-. She has joined VNIT, Nagpur on 23.04.2012 FN.

As per Office Order No. D/AP/Recruit (C) / March-2012/1833 dated 26 MAR 2012, her appointment shall be for a **maximum** period of five years on contract from the date of her joining and she has to acquire Ph.D degree on or before 22/4/2017.

The detailed note from Establishment section, her request letter for an extension till July 2018 to complete Ph.D work, Supervisor and Head of the Computer Science remarks are enclosed in **Annexure-IX.**

During 2015 Shri Pankaj Bahadure, Faculty of Architecture department was granted an extension of 9 months for completion of Ph.D work and award of the degree by the Competent Authority.

BoG is requested to deliberate.

The BoG further directed the institute to revoke the Office Note No. Dean/296 dated 18.01.2018.

59.13.02: To consider Relaxation to Internal Faculty during Faculty Recruitment.

The scrutiny of forms for faculty recruitment is near completion. The following one time relaxation measures are proposed.

- i) There are few faculty members who have claimed their credit points but did not attached enough / any proof of the same. They may be allowed to submit their documents toward their claim after the due date for submission is over.
- ii) If any faculty member is short by few credit point (i.e. upto 10% of total requirement for the post applied), BoG may authorize Director to permit such cases giving due consideration to other activities performed by these faculty in the Institute (which may include the activities which are not entitled for credit points).

BoG is requested to deliberate.

- i) BoG resolved that the Internal faculty who submitted prescribed application (within the submission deadline) for relaxation or mapping but have not attached documentary proof, are permitted to attach the documentary proof regarding the claims for their credit points.
