- (i) CPDA Norms listed in Sixth Pay Commission should be implemented and there is no scope for modifications. The matter pertaining to uniform policy for CPDA implementation with regards to contingency expenditure will be put up in NIT Council for further guidelines.
- (ii) Regarding testing and consultancy, the disbursement of the amount should be stopped immediately in the view of CAG observations. The further guidelines will be issued after deliberations in forth coming NIT Council meeting.

F 37. 03 Fees Structure of various programmes with regard to tuition fee waiver for Post Graduate(M.Tech. / M.Sc.) SC/ST category students in NITs.

Agenda: As per the MHRD letter no.F.No.33-4/2014-TS-III dated 16th June 2015 with regards to exemption in tuition fee for SC/ST Category students, it is mentioned that MHRD letter no.F.No.14-5/2013-SC/ST dated 13th January 2014 instructions should be adhered to, for facilitating admission for SC/ST candidates. (Annexure – II).

As per the content -" No Fees should be charged at the time of admission from those SC/ST students who are eligible for post-matric scholarship or top class scholarship. They may be advised to deposit the fees with the institute as soon they receive the scholarship. An Undertaking to this effect may be taken from them at the time of admission."

FC is requested to discuss and provide guidelines in the matter.

Resolution: The matter is referred to MHRD and till then the guidelines of MHRD letter no.F.No.33- 4/2014-TS-III dated 16th June 2015 should be followed.

F 37. 04 To approve the revised norms of CPDA expenses and procedure for reimbursement.
