## PhD (Part Time) Programs

(Starting from January 2019)

### A. Guidelines, Rules and Regulations for General Candidates:

A1) The candidate should have 5 years of experience before registering to the programme.

A2) Minimum duration of the programme (i.e. upto thesis submission): 4 years

A3) Place of work: VNIT Nagpur

A4) Course work is to be completed within 1 year of admission.

A5) Contact duration: minimum attendance in VNIT: 15 days per semester.

A7) No financial assistance / fellowship / Teaching assistantship will be paid from VNIT to candidates admitted under this category.

A8) Other guidelines, rules and regulations governing PhD (Full time) programs January 2019 are applicable to PhD (Part time) Programs January 2019, also.

A9) Eligibility criteria, admission process and schedule is same as of PhD (full time) program January 2019.

**B. Meity Ph.D. (Part time):** Some seats are available in the "Visvesvaraya Ph.D. scheme" of Ministry of Electronics and Information Technology (Meity) for the part time candidates. These seats are available in Center for VLSI and Nanotechnology, Department of Electronics and Communication, Department of Computer Science and Department of Electrical Engineering. These seats will be filled up as per the norms of the scheme and institute rules (A1 to A9) for this scheme.

**C. TEQIP-III Ph.D. (Part time):** Candidates appointed as Assistant Professor (Temporary) under TEQIP-III are eligible to apply for Ph.D. (part time) programs with following guidelines, rules and regulations.

- a) Candidate should be appointed as Assistant Professor (Temporary) under TEQIP-III with NOC from the Institute head.
- b) The all rules of Ph.D. (Part time) programs, except A1 and A3, are applicable.
- c) Financial support is limited to the completion of TEQIP-III and to be borne by the deputing or the respective institute.
- d) Guidelines provided by the letter NPIU/TEQIP III/Acad/442 dated June 5, 2018-Annexure-1 will be followed.
