

## **Summer Internship Program (SIP) at VNIT, Nagpur**

### **Brief:**

A scholar at undergraduate, PG or doctoral level enrolled in a reputed institution and who are looking for summer internship to work in collaboration with VNIT faculties is encouraged to apply for summer internship program (SIP) at VNIT as per the prescribed guidelines. The students would be given an opportunity to work for research/consultancy oriented project component under the able guidance concern supervisor.

The total time duration for SIP 2020- 18<sup>th</sup> May- 10<sup>th</sup> July 2020.

The duly completed (SIP) application form alongwith with fees from the interested scholar needs to be filled and should reach in hard copy format to Dean Academics, VNIT, Nagpur-10 on or before 25<sup>th</sup> April. The applications will be evaluated and selected scholars shall be intimated on by respective departments. The scholars need to complete the desired joining formalities by depositing fees (Rs. 5,000 + Rs. 900 (GST) = Rs. 5,900/- by Demand Draft favoring Director, VNIT) in consultation with respective supervisor on or before 15<sup>th</sup> May. The scholars who needs accommodation and mess facility at VNIT hostel needs to mention the same. The charges for hostel and mess facility will be as per institute policy and norms.

### **Application and selection**

- 1) Interested scholar should contact the faculty based on the topic/title of the project offered by the faculty
- 2) Scholar should seek consent from the respective faculty.
- 3) Scholar should submit dully filled form along with the faculty's consent.
- 4) Scholar's selection will be based on his academic record which includes his attitude for research, participation in technical festival, participation in conference etc.

### **General Instructions for students**

1. The period of work should not be less than 6 weeks including Sundays and Holidays under any circumstances. If the final duration turns out to be less than 6 weeks, the fellowship will not be deemed to have been satisfactorily completed to entitle to the certificate and fellowship dues.
2. All correspondence and enquiries should be addressed to Dean Academic, Visvesvaraya National Institute of Technology, South Ambazari Road, Nagpur 440010.
3. Summer interns must strictly follow the rules and regulations (oral and written) stipulated by VNIT, in working laboratory. If any mal practice on the part of the summer intern is reported, the VNIT will be constrained to terminate their fellowship.
4. Based on specific supervisor's satisfactory recommendation the scholar will be entitled for the award of certificate.
5. Any accident during the summer intern program will not be responsibility of VNIT or Faculty involved in programme. Student has to sign No Objection Certificate prior to start of SIP.

**For SIP selected scholars:**

1. VNIT will arrange the accommodations on payment basis for the selected summer interns in the institute hostel facility as per the norms.
2. The exact place of stay will be indicated by VNIT (Hostel Section/supervisor).
3. The detailed route maps to the VNIT from the (a) Nagpur railway station, (b) Nagpur Airport will be provided to you. If you face any difficulty you may contact coordinators/supervisor.
4. Scholar can collect your ID card from the Academic section situated in the Institute required for security purpose.

**SIP Certification**

After completion of the program, hard copy of the detail project report and no dues form duly signed by the guide, should be send to dean academics office. The SIP certificate shall be released for the successful scholars by post.
