I. Evaluation For Summer 2020 session

1. As per the report submitted by the specially appointed Committee, as per the Senate decision, the final evaluation of the non final year students * will be based on the following components along with weightages mentioned against each of them;

For UG/PG students

1	First Mid semester examination	30%	0.3 * marks scored out of 100
2	Assessment through assignments/quizzes	40%	0.4 * marks scored out of 100
3	Performance in previous semester	30%	0.3 * 10* CGPA ^ψ

For Ph.D and M.Tech by Research Students; and also for the students for whom CGPA data is not available; L type courses

1	First Mid semester examination	40%	0.4 * marks scored out of 100
2	Assessment through assignments/quizzes	60%	0.6 * marks scored out of 100

2. The course coordinator will calculate the total marks scored by the students out of 100 as per the above specified weightages and will decide the grade points cut-offs.
3. For P type courses, the evaluation carried out upto the second sessional examination is to be considered out of 100%.
4. Last date for display of the marks is 16/07/2020 and declaration of result is on 21/07/2020.
5. There will be no Summer Term for the first year (and also for the final year courses with following exemption) this time (S/2020) because of COVID -19 outbreak in India & particularly in Maharashtra. The eligible students for summer term 2020 will be permitted to write the summer term in the respective courses at the earliest opportunity available; likely to be in S/2021. [BT19/BA19 students will be granted suitable relaxation, limited to 12 first year credits during III sem registrations. For details please see registration instructions for W/2020 in the later part of this note].
6. Summer Term 2020 will be offered to only those eligible students who, by registering to the summer term courses, are completing the degree requirements; The Summer Term of S/2020 to start from 3rd August to 22nd August 2020.

II. Commencement of Session W/2020

With currently prevailing situation of COVID-19 pandemic in India & particularly in Maharashtra the W/2020 session, at least in part, needs to be completed in online mode. Accordingly rescheduling of the academic activities is carried out which is as under;

1. Newly proposed academic calendar for the session W/2020.

The salient features are:

- a) Registration to commence from 25th July 2020.
- b) Classes to commence from 17th August 2020.
- c) Six days a week.
- d) Only one mid semester examination; during 1st Oct to 9th Oct 2020.
- e) Teacher Assessment: Faculty members will give atleast 4 Assignments/ or conduct 4 Quizzes during the teaching days; 2 prior to Midsem & 2 after the Midsem examination.
- f) All practical sessions in the last week of November to first week of December 2020.
- g) End semester exam from 8th Dec - 18th Dec 2020.

2. Registration:

- a) Registration to commence from 25th July 2020.
- b) Fee payment 30% at the time of registration + 70% before 30th September 2020.

A. Registration of UG students (B.Tech/B.Arch)

a) 3rd Semester UG students, (BT19 or BA19);

- I. Will be required to register the first year courses in which 'W' grade is awarded.
- II. are permitted to register to all the 3rd semester courses if the valid first year backlogs¹ credits are < 12. (For courses in which W grades are awarded, the corresponding credits will not be counted).
- III. For valid 1st year backlog credits >12; students will have to first register to the backlog¹ credits over and above 12 & then to 3rd semester courses as per availability.

b) 5th Semester and onwards UG students, (Students registered prior to BT19/BA 19);

- i. Backlog courses to be registered first and then other available courses
- ii. Equivalent relaxation in the number of courses to be registered will be given if the¹ candidate is eligible to write summer term in the first year courses during S/2020.

¹ This however, will be executed through your respective faculty advisor. The students are requested to first register as the software permits and later apply for the said relaxation through FA, who inturn, at the time of registration approval, will make necessary changes. Please be in touch with your Faculty Advisor.

B. Registration of PG students (M.Tech/M.Sc) (MT 19 or MS 19 students)

- a) 3rd Semester - Backlog courses to be registered first & then other available courses.

3. Teaching:

A). L type courses (Theory);


- a) Theory classes to begin in 'online mode' from 17th August 2020.
- b) VNIT is procuring WebEx platform for the delivery of the lectures.
- c) The 'On-screen' time per lecture will be max 40 minutes.
- d) Slot-wise time table for online classes is attached as Annexure – I.
- e) The lecture will also be video recorded. The recorded lecture will be made available for offline viewing.
- f) Online/offline attendance will be recorded.
- g) Students are advised to keep sufficient memory space/bandwidth available for viewing/downloading the recorded lectures.

B). 'P' type course or practical component of L type courses (Practicals):

- a. Practicals are schedule during mid November to 1st week of December
- b. Faculty members may video record the practicals and upload on any mode of video display. Students to view the recording and complete the assignment given on the practical work and submit it online before the stipulated date or as specified by the course coordinator. [Virtual labs, if available, OR any other innovative method can be thought of]. If by that time COVID-19 situation eases out, physical practical classes can also be conducted in the institute.

C). Project:

- a) Depending on the facilities available & feasibility of completion, the supervisor may offer computer/fabrication based problems for Project Phase – I.
- b) The faculty members may also send soft copies of a few research papers to the students for study.
