Eligible students of above category who have not applied should visit site www.Mahadbtmahait.gov.in. Students who will fail to apply will not be eligible for availing Rajarshi Chhatrapati Shahu Maharaj Shikshan Shulkh Shishyavrutti Scheme under EBC and will be required to pay fees of the year 2018-19.

Eligibility :

1. Applicant should be Domicile of Maharashtra and applicant belongs to Maharashtra State and Karnataka state border can apply for scheme. Family annual income limit is upto Rs. 8.00 lakh.
2. As per Government Resolution first two children are eligible for scheme.
3. Candidate those who take admission under general category is eligible.
4. Courses from GR 07/10/17 (DHE courses) can apply.
5. Candidates are eligible those who have taken an admission under general category.
6. Courses by GR 07/10/17 (DHE courses) can apply.
7. Applicant should not avail any other scholarship or stipend.
8. Students are not eligible who has taken an admission in Distance Education, virtual learning and part time courses.
9. The Courses approved by (Government /University/AICTE,PCI/COA/MCI/NCTE/ etc) are eligible.
10. During course, candidate should not have a gap of 2 years.
11. Applicant should attempt every semester or annual exam
