For the students having enrollment numbers starting from

- 1. BT19, BT18 and other students in III/ IV year of B Tech.**
- 2. BA19, BA18, BA17 and other students in III/IV/V year of B Arch**
- 3. MT21, MS21 and other students in I year M Tech / M Sc**
- 4. MS20, MT20 and other II year M Tech / M Sc students who need to be on campus for course work/ project.**

Subject: On campus classes starting from 3rd January 2022.

The even semester of all the students specified above will be conducted on campus in physical mode. Full vaccination of the student is mandatory before entering the VNIT campus.

For students availing hostel facility

1. Before starting the journey, make sure you are fully vaccinated and recovered from the effects of vaccination, if any. Keep a copy of vaccination certificate with you.
2. Fill up and sign the undertaking provided in Annexure-I of this notice.
3. Vaccination certificate and the undertaking are mandatory for arriving at the campus.
4. Since every student will be allotted single room, many students will have to shift to some other hostel, as planned by the hostel section. Hence, all the final year students have to report from **20 to 25 December 2021** and all the third year students will have to report from **26 to 30 December 2021**.
5. When you arrive at VNIT campus, report to the hostel section.
6. You will be allotted a room temporarily and you will have to immediately undergo RTPCR test.
7. You will stay isolated in your temporary room, till the RTPCR report is received.
8. In case your test is +ve, you will have to comply with all the instructions and directives of VNIT Health Center.
9. In case your test is -ve, you have to shift to the finally allotted room in the hostel, report to your department and faculty advisor.
10. You have to get the signature of your faculty advisor and HoD on Annexure-I . Submit hard-copy of the filled-in form to the department and send scanned copy by email as instructed. You can start attending classes by following all the COVID related norms in the campus.

For students NOT availing hostel facility

1. Before reporting to the department, make sure you are fully vaccinated and recovered from the effects of vaccination, if any.
2. When you report to your department, you must have certificate of full vaccination and an RTPCR -ve report, not older than 72 hrs. from the time of reporting.
3. You will have to submit the undertaking as given in Annexure-II of the notice. Submit hard-copy of the filled-in form to the department and send scanned copy by email as instructed. You can start attending classes by following all the COVID related norms in the campus.

Once on campus, all the students will have to comply with COVID related norms issued from time to time, by the institute and the local authorities. Frequent RTPCR tests may have to be done as directed by local authorities.
