## Attention : All candidates allotted seat under PH category at VNIT Nagpur in 2021

All candidates allotted seat under PwD category at VNIT Nagpur are required to undergo medical examination by the Medical Board at VNIT Nagpur (if not done by the Medical Board of VNIT during JoSSA / CSAB schedule). Since it is decided by the Institute, that candidates shall undergo for online reporting to Institute instead of physical reporting, the medical examination of the candidates admitted in PH category would be undertaken when they report physically to the Institute.

The candidates and the parents are requested to note that only provisional admission will be granted during the online reporting. The admission shall be confirmed subjected to verification of documents with original documents during physical reporting later.
