- Dr. D.K. Sharma, Representative GoI stressed the need of using the infrastructure of the Institute more comprehensively and expected excellent laboratories, Computer centres, Workshop for imparting quality education which can directly be transferred to the students.

Item 01.01 To Note the status of the 85th Meeting of the Board of Governors held on 16th July 2002 in Mantralaya, Mumbai.

As regards (f) the Board ratified the annual accounts of the College for the year 2001-2002. Status report of MHRD / AICTE project schemes was approved. The Board authorised the Director to take up the matter of payment of Service Tax on Testing and Consultancy income of the Institute with appropriate authorities at local and national level. It was resolved to pay the taxes on consultancy income and go in appeal, if necessary.

As regards (g) (85.06) the Board directed the Institute to take necessary action in respect of Carrier Advancement Scheme of GoI as per the recommendation of AICTE subject to any modifications arising out of the decision of the NIT Council. The Board further requested the Director to expedite the action in respect of constitution of Selection Committee as per statute, in view of considerable delay that has already been taken place.

Item 01.02 To approve the minutes of the first meeting of the Senate held on 3rd September 2002.

The Board approved the minutes.

Item 01.03 To formulate the Finance and Building and Works Committee.

The Board recommended the nomination of Shri V.R. Jamdar on Building and Works Committee under the provision of MoA Rules 7 (1) (a).

Item 01.04 To consider the Nomination of Alumnus on Board of Governors.

The Board unanimously approved the nomination of Shri R.W. Khare on the Board of Governors under provision 9 (h) of the MoA.

Item 01.05 To consider the appointment of teachers and officers against sanctioned post.

The Board permitted to make the appointments of faculty and other academic staff against the sanctioned vacant posts and directed to follow the norms of reservation as applicable in IIT, Mumbai.

The Board also permitted to convert one sanctioned post of Prof. of Architecture into Prof. (Design Chair) provisionally for a period not exceeding 3 years and to be filled on contract with no additional financial liability.

Item 01.06 To approve the creation of the Deputy Director & Deans:

The Board approved the proposal as an Ad-hoc arrangement till the NIT Council decision in this regard is received for implementation.
