- 3. Indoor sports facilities at estimated cost of ₹ 400 Lacs.
- 4. Boys Hostel with 500 capacity with mess facility (Phase-3) at the estimated cost of ₹ 2000 Lacs.
- 5. Lecture hall complex (G+6) at the estimated cost of ₹ 1000 Lacs.
