S 06.01 To note the draft minutes of the 5th meeting of the Senate held on 28th September 2004.

The Senate noted and approved the draft minutes of 5th meeting of the Senate held on 28th September 2004.

S 06.02 To note the Action Taken Report on the decisions of the 4th meeting of the Senate held on 28th September 2004.

The Senate noted the Action Taken Report on all items.

S 06.03 To approve the minutes of the Senate Standing Committee, meeting held on 11th May 2005.

The Senate approved the minutes of the Senate Standing Committee meeting held on 11th May 2005 with the suggestion that the eligibility criteria for Ph.D. programme shall be 1st class degree at B.E. / B.Tech. level (or equivalent) and post-graduation in respective branch of engineering.



S 06.04 To consider modifications proposed in the Scheme of Examination for B.Tech. in Electronics Engineering, Metallurgical & Materials Engineering and Mining Engineering.

The Senate opined that there should not be frequent changes in the Scheme of Examinations, although minor changes in syllabus may be incorporated. The Senate approved the proposed modifications for B.Tech. in Electronics & Communication Engineering, Metallurgical and Materials Engineering, Mining Engineering and the inclusion of "Environmental Management" in B.Tech. (Mechanical Engg.), changes in M.Tech. (Heat Power Engineering) and reduction of duration of theory papers in (a) Structural Design – I and (b) Estimating, Contract and Costing as proposed by the respective Board of Studies, as a special case. The Senate resolved that henceforth an approved Scheme of Examinations will remain unchanged for 3 years in the case of UG programmes and 2 years in the case of PG programmes.

S 06.05 To consider the change in title of B.Tech. (Electrical Engineering) programme to B.Tech. (Electrical & Electronics Engineering).

The Senate approved the proposal in principle and suggested to implement the same from the batch admitted in the year 2004-05, subject to necessary approval / clearance from AICTE.

S 06.06 To start M.Tech. programmes in (i) Geo-informatics and (ii) Computer Science and Engineering.

The Senate approved the M.Tech. programmes in (i) Geo-informatics and (ii) Computer Science and Engineering in principle. The Senate strongly recommended that proposals for starting new programs should be placed before the Senate only when they are complete in all respects in the format prescribed by AICTE.

While deliberating the issue regarding starting of M.Tech. programme in Excavation Engineering in the Department of Mining Engineering the Senate in approving the proposal in principle, advised the Chairman, Board of Studies of the Department of Mining Engineering to review the proposal in consultation with Department of Mechanical Engineering.

S 06.07 To start full time MBA course and to establish Department of Management Studies & Entrepreneurship Centre.

The Senate approved the proposal to start full time MBA course in principle with the condition that the management course should be exclusively limited to engineering graduates and should include subjects specifically related to management of engineering enterprises.

(A) To consider the expert nominee of Senate on Selection Committee.

(B) To consider the proposal for starting new undergraduate programme in Chemical Engineering.

The Senate approved in principle the proposal to start a B.Tech. programme in Chemical Engineering with the suggestion that subjects like Industrial Waste Treatment and Air Pollution be included in consultation with the Department of Civil Engineering. Further, it was suggested to explore the possibility of using the existing laboratories in the Department of Metallurgical and Materials Engineering and Chemistry for the proposed programme.

(C) To consider the proposal for pro-active monitoring of examination results received from a member of the Board of Governors.

The Senate noted with appreciation the spirit of the proposal and re-affirmed that a formal mechanism (Central Examination Cell) already exists for monitoring of examination results, as envisaged in the proposal.
