The Committee resolved to allot the work to the contractor carrying out specialized work irrespective of his registration with Govt. Agencies.

(C) Extension of New Library building.

The Committee approved the proposal to construct one more floor (G+2) on the new Library Building in view of the anticipated increase in students intake.

(D) Arrangement for students' accommodation.

Due to the shortage of accommodation for students in hostels the existing three multistory apartment buildings are recommended for the use of accommodating students. Such students would pay rent as per existing rates of hostel accommodation. I quarter each for messing facility and for the Warden, adjacent to these buildings is approved to be identified and use with suitable modification / alteration.

(E) Procedure of tendering.

The Institute is permitted to use item rate tender as against percentage tender in view of the flexibility in rates.
