BWC 51.01 To confirm the minutes of 50<sup>th</sup> meeting of the Building and Works Committee conducted on 20th July 2018.

BWC 51.02 The Action taken report on the minutes of 50<sup>th</sup> meeting of the Building and Works Committee.

BWC 50.02 To approve Extension of Time for Construction and Upgradation of Sewerage System and Sewage Treatment Plants (STP-600 KLD) at VNIT, Nagpur Campus.

The Institute is in receipt of letter from M/s NBCC Ltd. requesting an extension of time for Construction and Up gradation of Sewerage System and Sewage Treatment Plants (STP-600 KLD) at VNIT, Nagpur Campus (letter along with revised schedule for STP work is enclosed. (Annexure II).

M/s NBCC Ltd. has awarded contract to M/s Rekha Enterprises for construction and up gradation of System and Sewage Treatment Plants (STP-600 KLD) at VNIT, Nagpur Campus. The approval for tree cutting has been received on 6th April, 2018 which stated that the tree cutting work can be started after 15 days of issue of the letter by NMC. Accordingly, the tree cutting work has been started on 19th April, 2018 and completed on 11.05.2018.

As per the condition of contract with M/s Rekha Enterprises the site for construction and upgradation of System and Sewage Treatment Plants (STP-600 KLD) should be handed over free of encumbrances; however in case of any delay in handing over the site to the contractor suitable extension of time shall be granted for execution of work.

Hence, M/s NBCC Ltd. has requested to grant an extension of time (EOT) up to 30th November, 2018 without imposing any Liquidated Damages.

BWC is requested to deliberate and approve.

However, few discrepancies were observed after handing over the project by M/s NBCC Ltd. It is noted that these buildings are not provided with appropriate systems / plumbing installation for storage & utility of NMC water.

Hence, BWC directed M/s NBCC Ltd. to give temporary connection for the same within 3 days i.e. on or before 23<sup>rd</sup> July, 2018 and complete the actual work related to installation, plumbing for storage & utility of NMC water within 08 days. Accordingly, the letter has been issued by VNIT, Nagpur to M/s NBCC Ltd. Further, this work has to be completed by NBCC Ltd. without any cost to VNIT, Nagpur
