#### F 55.02 To note the action taken on the resolutions of 54th meeting of Finance Committee.

F 54.03 To recommend increase in the remuneration to be paid to the examiner for conducting the open defence and the viva-voce examination of a Ph. D/M Tech (by Research) scholar.

The 52nd Senate has put up the proposal vide item no.S 52.06.03 regarding increase in the remuneration to be paid to the examiner for conducting the open defence and the viva-voce examination of a Ph. D/ M Tech (by Research) scholar at VNIT Nagpur the details of which are as given below:

S52.06.03: To approve increase in the remuneration to be paid to the examiner for conducting the open defence and the viva-voce examination of a Ph. D/M Tech (by Research) scholar;

It is proposed to increase the remuneration to be paid to the examiner for conducting the open defence and the viva-voce examination of a Ph. D/M Tech (by Research) scholar, from Rs. 2000/- to Rs. 5000/-.

#### F 55.06 To approve the payment of 14% monthly contribution of basic + DA to NPS A/c Holders.

The Establishment Section has put up the note (Annexure-V) along with the gazette notification issued by Dept. of Financial Services dated 31<sup>st</sup> January, 2019 regarding payment of 14% monthly contribution of basic + DA by Employer to NPS A/c Holders w.e.f. 1st April, 2019.

The salient feature of this notification is as given below:

"The monthly contribution would be 10 percent of the basic pay plus Dearness Allowances (DA) to be paid by the employee and 14 percent of the basic pay plus D.A. by the Central Govt."

VNIT is governed by NIT Act and NIT Statutes and the employees appointed on or after 01/01/2004 are governed by New Pension Scheme (NPS).

Hence, The Finance Committee is requested to recommend to BoG the increase of employer's contribution to 14% of the basic pay + DA w.e.f. 1st April, 2019 and also the other provisions as mentioned in this gazette notification.

FC resolved that the matter regarding applicability of the provisions of gazette notification issued by Dept. of Financial Services dated 31-01-2019 to Institute employees may be referred to MHRD, for clarification.
