- 2. M. Tech students are allowed to undertake Summer internship in reputed industries/ Institutes/ research organizations after the II semester, but before commencement of the third semester. The students will be paid Institute stipend in full and are not required to apply for leave during this internship period. The concerned HoD to decide the "reputed industry" with proper justification. If the concerned industry is ready to offer the stipend to the student, the Institute stipend will not be paid.
- 3. The M.Tech project Phase–I & Phase-II both can be carried out in industry with Institute stipend. Maximum two students will be permitted. The students will carry out the teaching assistantship during the Summer vacation period after 2nd semester. The students who have undertaken the Summer Internship after 2nd semester, will not be eligible. Other rules as applicable to project phase II students (as per Annexure-III of the rule book) will be applicable in such cases also.

Other relevant issues like, required modifications in the M Tech schemes, monitoring of the students doing their project at VNIT, number of students that can be sent to industry for their M Tech dissertation <u>without</u> stipend, etc., will be finalised by the APPEC.

4. The CGPA Requirement for the award of M.Tech. degree remains 6. However, the students are permitted to improve the grades by registering to new courses or even to the courses in which they have already secured a PASS grade (i.e. AA to DD). The maximum duration to complete the M Tech degree remains 3 years from the date of his/her first registration. APPEC to discuss and recommend the operational mechanism.
