VNIT Nagpur has not received any response from the Ministry of Education on these matters till date.

Hence, the BoG is requested to deliberate.

**Resolution :** i) In case of internal faculty of the institute, it is cleared by Ministry of Education that all the recruitment done at NITs is under Direct Recruitment as per Four Tier Faculty Recruitment and is not to be considered as promotions. The fixation of pay and date of increment has to be carried out as per the OM No.F.No.15-4/2017-TC dated 27th October 2017.

- ii) Regarding recruitment of faculty positions at higher level, this issue pertains to all NITs and IITs. Ministry of Education is examining the issue and will issue the directives, accordingly.
- iii) The issue related to one time measure regarding faculty members of VNIT Nagpur , which was referred to Ministry of Education vide letter No.D/08 dated 18<sup>th</sup> February 2020 has been once again discussed in the meeting for seeking clarification from Ministry of Education.
