The Institute is in receipt of letter No. MRSAC/VNIT-lease/850/2018-19 dated September 28, 2018 (Annexure-VIII) from Maharashtra Remote Sensing Applications Centre, Nagpur regarding the renewal of lease deed.

BoG is requested to deliberate.

Resolution: BoG does not agree to renew lease deed for Maharashtra Remote Sensing Applications Centre, Nagpur. However, BoG resolved that the period of one year from the date of confirmation of this minutes be given to MRSAC, Nagpur for relocating their premises and fresh agreement to that effect between VNIT Nagpur and MRSAC, Nagpur be made. BoG further resolved that the, Maharashtra Remote Sensing Applications Centre, Nagpur should pay the rent as per CPWD rate with effect from the date of expiry of lease. i.e. 25th September, 2018.

Accordingly, as per Item No. 66.02 the legal agreement has been prepared and sent to MRSAC vide letter No. Admn/MRSAC/2019/1458 dated 18th March, 2019 requesting them to release rent of Rs. 7,13,932/- p.m. w.e.f. 25/09/2018. The reminder for the same, vide letter No. Admn/MRSAC/2019/2285 dated 25th April, 2019 and Admn/MRSAC/2019/3486 dated 28th June, 2019.

VNIT, Nagpur has received a letter No. MRSAC/GB(47th)/4195/2019-20 dated July 8, 2019 and accordingly the item has been placed in 69th meeting, details of which are as follows:

69.07 Regarding expiry of lease deed and non payment of rent by Maharashtra Remote Sensing Applications Centre (MRSAC), Nagpur.

As per the 66th meeting of Board of Governors Item No. 66.02, VNIT, Nagpur has sent a letter dated 18th March 2019 to MRSAC along with the rent agreement format for payment of rent along with the arrears from 25/09/2018. The rent has been calculated based on the CPWD rate which works out to be Rs. 7,13,932/- per month with effect from date of expiry of original lease. Subsequently, the reminder letters dated 25th April, 2019 and 28th June, 2019 were sent. However, till date the rent has not been deposited by MRSAC, Nagpur.

Presently, Director, VNIT, Nagpur has received the letter No. MRSAC/GB(47th)/4195/2019-20 dated July 8, 2019 along with the approved minutes of 47th Governing Body of MRSAC, Nagpur. (Annexure-IX)

The MRSAC BoG Item No. 47.4.1 is as given below:

47.4.1 The Director MRSAC & Member Secretary, Governing Body of MRSAC apprised the Governing Body about the issue of renewal of lease of land of 0.3 hectare located in the premises of VNIT, Nagpur (formerly known as VRCE) and is in possession of MRSAC. He further apprised about the decision of the Board of Directors of VNIT regarding vacating of the premises by MRSAC.

The Chairman, MRSAC & Hon'ble Chief Secretary, Government of Maharashtra advised Director MRSAC & Member Secretary, Governing Body of MRSAC to locate a suitable land in Nagpur City including vacant land belonging to State Government of Maharashtra, Dr. Punjabrao Deshmukh Krishi Vidyapeeth Akola or Maharashtra Animal Husbandry and Fisheries Science University or any State Government Bodies / Agencies which can be considered for allotment to MRSAC and accordingly submit proposal to the Planning Department.

BoG is requested to deliberate.

Resolution: BoG noted the contents of MRSAC BoG Item No. 47.4.1 & BoG resolved that the Institute should send a letter to MRSAC regarding payment of rent along with the arrears from 25/09/2018.

Subsequently, the letter No. Admn/MRSAC/2019/5459 dated 23rd September, 2019 has been sent with a request to release the rent from 25/09/2018. Further, letter No. Admn/2019/497 dated 27th January, 2020 followed by reminder letter No. Admn/2020/3144 dated 14th August, 2020 has been sent with a request to release rent w.e.f. 25/09/2018.

VNIT, Nagpur has received a letter No. MRSAC/VNIT-lease/396/2020-21 dated August 18, 2020 regarding execution of Deed of Rent along with a draft copy of rent agreement. VNIT Nagpur has approved the rent agreement and corrected copy has been sent vide letter No. Admn/3283 dated 27th August, 2020 with a request to release the rent of Rs. 7,13,932/- p.m. w.e.f. 26/09/2018 and execute a rent agreement with a stamp duty to be paid by MRSAC Nagpur as per the Bombay Stamp Act 1958. The letter No. Admn/3979 dated 29th October, 2020 is again sent with a request to execute the rent agreement as per the approved agreement format (Annexure-VII) but till date MRSAC Nagpur has not processed the execution of agreement for paying the rent of Rs. 7,13,932/- p.m. w.e.f. 26/09/2018.

Hence, it is proposed to issue the legal notice to MRSAC Nagpur.

Resolution : BoG asked the Institute to issue legal notice to Maharashtra Remote Sensing Applications Centre (MRSAC), Nagpur.

75.09 Non-payment of lease rent of Rs. 98,721/- per month by MSEDCL from 1st January 2019.

As per the BoG Item No. 71.10, VNIT Nagpur has discussed the matter related to non-payment of lease rent of Rs. 98,721/- per month from 1st January 2019. Accordingly, the letter No. Admn/3223 dated 20th August 2020 was issued to Executive Engineer (Civil) asking MSEDCL to pay lease rent from 1st January 2019 (Letter attached).

The officials from MSEDCL has requested VNIT Nagpur to have a joint meeting with higher authorities of MSEDCL to take appropriate decision regarding the lease rent. Accordingly, VNIT Nagpur is issued a letter No. Admn/Maha Vitaran/3960 dated 28th October 2020 (Letter attached) informing the date of meeting as 3rd November 2020 at 4.00 PM, Venue: Director's Office. (Annexure-VI) Accordingly, the authorities from MSEDCL attended the meeting and discuss the matter related to reduction of lease rent.

Director, VNIT Nagpur along with Dean (P & D) and Registrar apprised the MSEDCL officials who attended the meeting stating that the VNIT Nagpur has extended 50% concession i.e. 50% of total rent of Rs. 1,97,442/- works out to Rs. 98,721/- p.m. Further, the GST is payable on entire amount on actuals by MSEDCL and MSEDCL has to pay appropriate stamp duty for execution of lease agreement.

The MSEDCL officials were asking for further reduction of lease rent, which was denied by VNIT authorities.

Now, the institute has received the letter No. SEC/CCCM/CIR/NGP/Tech/No/0165 dated 01 February 2021 in the name of Chairman and Director, VNIT, Nagpur requesting revision of lease rent. (Annexure-VIII)

The BoG is requested to deliberate.

Resolution : BoG does not agree to renew lease deed for MSEDCL as per the previous lease rent i.e. Rs. 1/- per year.

BoG resolved that the Institute should send a letter to higher authorities of MSEDCL regarding non payment of lease rent of Rs. 98,721/- per month from 1st January, 2019.
