#### S61.08: Proposal to adopt MOOC Courses as a part of curriculum.

The BoS of Electronic & Communication Department has proposed to adopt MOOC Courses as a part of curriculum. [Annexure - VI]

Also, APPEC suggested that the MOOC course must have minimum 40 contact hours to consider it as 3 credit course and minimum 56 contact hours to consider it as a 4 credit course.

# S62.07: Modified Academic Calendar Winter 2021 for Higher Semester UG & PG (Online Mode) and Schedule for Practicals & Project Evaluation 2020-2021 (ODD Semester). (Annexure – V (a & b)

It is now quite clear that the next semester will also have to be conducted in online format. Hence, the academic calendar for Winter 2021 is modified. There are online classes on Saturdays also and there will be only one mid-sem examination, same as earlier online semesters.

We will again have the same evaluation procedure as was specified for S/2021 vide note of Dean (Acd) dated 20/01/2021. (Annexure -V(c)).

The APPEC discussed & suggested a few minor corrections. The corrected proposal is placed before the senate for approval.
