78.07 To consider legal opinion of Advocate Anand Parchure regarding Non-payment of lease rent by MSEDCL since 1st January 2019 for the land in the premises of VNIT, Nagpur for sub-station and official use of MSEDCL.

Director (Operations), Maharashtra State Electricity Distribution Co. Ltd., Mumbai has once again requested VNIT Nagpur, vide its letter No. CE(Civil)/VNIT/Lease/17342 dated 29.07.2021 to renew the lease at a nominal rent of Rs.1/- per year.

As per the directives of Board of Governors, VNIT Nagpur, the institute has provided 50% concession of lease rent to MSEDCL based on the calculation done as per CPWD norms i.e. from Rs. 1,97,442/- to Rs. 98,721/- per month w.e.f. 01/01/2019.

VNIT, Nagpur has requested Advocate Anand Parchure for legal opinion regarding the renewal of lease agreement and legal opinion is enclosed herewith (Annexure-VIII). Due to non-payment of lease rent by MSEDCL even though the institute has done continuous follow up and after issuing two legal notices, Advocate Anand Parchure has advised to file a suit before the competent court.

The BoG is requested to deliberate.

**Resolution :** After brief discussions, BoG resolved that the VNIT Nagpur should file a suit before the Competent Court.

78.08 Matter related to Shri P.D. Jaronde, Lab. Asstt. SG-II.

VNIT, Nagpur has written a letter No. D/2415 dated 25<sup>th</sup> March, 2021(Annexure –IX) seeking clarification related to grant of financial up-gradation in case of Shri P.D. Jaronde, Lab. Asstt. SG-II. VNIT, Nagpur has received a reply No. F.No.11-7/2018-TS.III dated 30<sup>th</sup> July, 2021 (Annexure –X) advising Institute to take action as per the rules and regulations and place the matter before BoG. The Ministry of Education further stated that the documents/rule positions provided by the Institute in connection with the pay fixation of Shri P.D. Jaronde seems to be in order. The pay fixation calculations of Shri P.D. Jaronde are as enclosed in Annexure -XI. Since Shri P D Jaronde was promoted to the post of Lab Assistant SG-II in PB-I + GP of Rs. 2800/-w.e.f. 24.02.2015, he was not eligible for MACP on 20.01.2017. Now as per Recruitment Rules, he is due for promotion as Technician (Selection Grade-I) with GP of Rs.4200/-on conduct of DPC which is his third financial up-gradation.
