83.11 To approve Family Pension in respect of Ms. Minakshi T.Kawarti.

Late Shri Tejram M. Kawarti was appointed in this Institute on 17.09.1966. After the death of Shri Tejram M. Kawarti, Smt. Jamunabai T. Kawarti wife of Late Shri T. M. Kawarti had applied for family pension. As per rule, on receipt of application and relevant documents, Institute had sanctioned family pension w.e.f. 18.05.1990 to Smt. Jamunabai T. Kawarti.

The Family declaration has not been submitted by Shri Tejram M. Kawarti during his service period.

Institute has noticed that name of Ms. Minakshi T. Kawarti was not mentioned in family declaration form submitted by Smt. Jamunabai T. Kawarti which was obtained at the time of sanctioning of family pension.

Shri Tejram M. Kawarti died in service on 17.05.1990. Ms. Laxmi T. Kawarti, unmarried daughter of Late Shri T.M. Kawarti and Smt. Jamunabai T. Kawarti was appointed as Attendant in Mathematics Department of this Institute on Compassionate ground vide Office Order No. Estt/C/6128 dated 24.09.1997.

During Compassionate appointment of Ms. Laxmi T. Kawarti, she has submitted the Family Declaration stating that they are six sisters in which Ms. Minakshi T. Kawarthi's name is shown at 4th place with age 16 years as on 15-09-1997.

Further, Ms. Minakshi. T. Kawarti has submitted Legal Heir Certificate dated 15th/28 February, 2019. Accordingly, based on the Legal Heir Certificate submitted by M. T. Kawarti legal opinion was taken from Adv. Anand Parchure and as per his opinion family pension cannot be granted to Ms. Minakshi. T. Kawarti. The establishment Section has putup note sheet Estt/PEN/B dated 05 Nov 2019 based on the legal opinion of Adv. Anand Parchure and the family declaration submitted by late Smt. Jamunabai T. Kawarti not having name of Ms. Minakshi Kawarti, the family pension is not sanctioned.

Accordingly letter No 6727 dated 17 Dec 2019 was issued to Ms. Minakshi. T. Kawarti regarding non grant of family pension. Presently the institute has again received letter dt.25/8/21 from Ms. Minakshi. T. Kawarti requesting to release family pension claiming that she is the dependant unmarried daughter of Late Shri T. M. Kawarti.

The note from Establishment section recommending family pension for Ms. Minakshi. T. Kawarti is enclosed. (Annexure-IX).
