BWC 67.02 The recommend construction of Adjacent Complex near Swimming Pool at VNIT Campus - Phase II.

BWC meeting vide Item No. 62.02 dated 11th February 2021 & Item No. 63.02 dated 12th March 2021 has recommended construction of Swimming Pool at VNIT campus to the Finance Committee. The Finance committee Vide Item No. F65.04 dated 24/06/2021 has recommended the same to BoG, for its approval. The construction of Swimming Pool was approved by BoG Vide Item No. 78.04 dated 14th September 2021. The Construction work of the Swimming Pool is fully funded by VNIT Alumni.

Now the Construction of adjacent Complex is proposed near the Swimming Pool. The VNIT Alumni is providing all Funds, Technical support and project execution for this Phase II proposal. The detailed Drawing & Cost Estimate is enclosed. (Annexure-II)

The Building & Work committee is requested to recommend the same to Finance Committee.

Resolution: BWC approves drawing & Cost Estimate and recommends construction of Adjacent Complex near Swimming Pool at VNIT Campus - Phase II to Finance Committee with the full financial support by VNIT Alumni.

Since the construction will be executed by VNIT Alumni Association, Institute will not be liable for lapses (if any) in the procedural formalities.

BWC 67.03 To recommend the proposal and detailed estimate of "Addition & Alteration to the TA Quarters" at VNIT, Nagpur.

The existing TA quarters are one BHK flat i.e. Bedroom, Hall and Kitchen. Presently, these quarters are allotted to Assistant Professor who joined our institute recently and since other quarters were not available for them.

Hence, after due consideration, it is proposed to add one Bedroom and Toilet to these existing TA quarters. Total TA quarters are 48 Nos. Accordingly, the proposal for 48 bedrooms and 48 toilets is prepared. The existing structure of these building is Ground Floor + First Floor + Second Floor. Thus, the proposed total built up area is 945 Sq. Meter and each TA quarter will get additional area of 20 Sq. Meter. The detailed estimate is prepared on the basis of SSR of State PWD 2021-22 and is placed at **Annexure-III.** The Estimated cost of Civil and Electrical work is Rs.265 Lakhs (Plus GST as applicable).
